# **Environmental Scan final report & Creating Our Network Statement** – Diana Rawlings, Arukah

"A **Network Statement** is a short narrative that describes the underlying reasons for, and aspirations of, your network in a compelling way. The **purpose** of a Network Statement is to create a communication piece that enlists support and engagement for your Network, similar to a leadership story, an elevator speech, or a fundraising prospectus. A Network Statement includes:

- Your Network's reason for existence
- The vision of your ideal future
- How your Network contributes to your ideal future
- Why your Network is best suited for that role
- What your Network has accomplished toward achieving your ideal future

Example Network Statement for C5 Rural:

Mental health affects our ability as humans to think, interact with each other, earn a living and enjoy life (WHO,2018). Unfortunately, mental illness is now the leading cause of disability in the US, with increased rates of depression,



suicide and substance use in rural communities such as the Bureau, Putnam and Marshall County area. Children and young adults (ages 16-24) are experiencing a high rate of mental illness, especially anxiety and depression, and oftentimes lack the resources to get care.

The C5-Rural healthcare network came together in 2019, to identify and break down the barriers that prevent youth from getting the mental healthcare they need. We embarked on this mission by establishing a network of partners that include primary care, mental health, complementary and communitybased providers to develop strategies that utilize both conventional with complementary medicine. Our momentum is growing as we expanded our partnerships in 2020 to include schools, churches, places of employment and other community groups working on this issue. Together, we are focusing our efforts on reducing the stigma associated with mental illness, finding innovative ways to work together, utilizing the resources available in our community, and creating new resources for a healthier future for everyone.
